SECRETARY'S REPORT

Motion by Spencer Lawrence to approve the ordinance for submission to the Streator City Council so a library referendum can be placed on the ballet of the March 17, 2020 election. Seconded by Gloria Gubbels. Motion passed by voice vote.

Motion by Ellen Park to grant Director Cynthia Maxwell vacation time from December 19. 2019 to January 6, 2020. Seconded by Spencer Lawrence. Motion passed by voice vote.

Motion by Spencer Lawrence to increase the salaries of Melissa Badger and Ashley Meiners on January 1, 2020 to \$10.00 per hour. Seconded by Ellen Park. Motion passed by voice vote.

Motion by Spencer Lawrence to raise Melissa Badger and Ashley Meiners hourly wage to \$10.75 on July 1, 2020. Seconded by Theresa Lukach. Motion passed by voice vote.

Motion by Spencer Lawrence to grant a 2.5% raise to Library Director Cynthia Maxwell. Seconded by Ed Brozak. Motion passed by voice vote.

All other employees will have hourly wages raised to \$9.25 as of January 1, 2020.

There being no other business, the meeting was adjourned at 6 p.m.
